

## **Statute of the competition POWERPLAY MANAGER, s. r. o. and collaboration with the International Biathlon Union (IBU)**

The purpose of this statute is to regulate the rules of the competition in the Winter Sports Mania game and other relevant channels (Discord, Social networks) (hereinafter referred to as "the competition") of POWERPLAY MANAGER, s.r.o., also trading as PowerPlay Studio. Link to this statute, together with the information provided in the Winter Sports Mania and specific competition posts, in accordance with Article II, Clause 2 of this statute, is the sole document that governs the rules of the competition to ensure that the competition conditions are precisely and clearly defined.

### **I. Promoter and organizer of the competition**

The promoter and organizer of the competition is POWERPLAY MANAGER, s.r.o., with its registered office at Budatínska 57, 851 06 Bratislava, Identification Number (IČO): 36722405, VAT Number (IČ DPH): SK2022302337, registered in the Commercial Register of the City Court Bratislava III, Section Sro, Insert No. 43978/B (hereinafter referred to as "the competition promoter") in cooperation with the International Biathlon Union (hereinafter referred to as IBU or as "the competition collaborator"), which is registered at the in the Austrian Register of Associations under ZVR number 291698201, and whose registered office is at Sonystraße 20, 5081 Anif (Salzburg), Austria.

### **II. Purpose of the competition**

1. The aim of the competition is the promotion of the first IBU eGame (named: IBU eCup).
2. The competition is usually announced in the text of a selected published post or status o (hereinafter referred to as the "competition post") or on the relevant channels or directly in the Winter Sports Mania game of PowerPlay Studio.

### **III. Duration of the competition**

Duration of the competition is from 1.1.2025 - 31.03.2025.

### **IV. Eligible participants**

1. All players of the Winter Sports Mania game can participate in the competition.
2. Any individual who is 18 years of age or older and fulfills the participation requirements specified in Article V of this statute (hereinafter referred to as "the competition participant") can participate in the competition. Persons listed in Article VII, Clause 1 of this statute are not eligible to participate in the competition.

### **V. Course of the competition**

1. The competition participant can participate in the competition in the following ways:

A) By participating in the IBU eCup, which is an IBU sponsored tournament that will be free to enter for all players of the game. Players will be divided into groups of up to 30 players with the potential for new players to be added to existing groups during the day (so the size of the groups may swell to over 30). Every day there is a new random draw of these groups. Players will be awarded according to the monthly rankings in the relevant months (January 2025 - March 2025).

The tournament will last for 24 hours (competing: 12:00pm (at midday-noon) -11:50am, following with the result calculation until 12:00pm) —during which the players will be required to do just 1 race and record the best possible time. Players will have an option to replay the race for a special in-game currency where they can improve their time. Players can earn the currency through

gameplay or purchase it directly if they want to. At the end of the game day, players will be awarded points based on the IBU official points scale and their final position within their group:

These points will be added to the overall monthly ranking.

B) Lottery for All IBU eCup players with at least 100 points during the whole competition duration.

All registered users with a minimum of 100 points in the IBU eCup tournaments (from 1st Jan 2025. to 31st of March 2025) will be participating in the final drawing.

2. The delivery of correct prizes and their functionality is the responsibility of the competition collaborator.
3. Each competition participant can participate
  - 3 times in part A (By participating in the IBU eCup). Each user is eligible for 1 monthly prize only ( If user A wins the 1st prize in December, he/she is not eligible for monthly prizes in Jan, Feb, Mar). Non eligible users won't be considered in the ranking drawing of the upcoming months)
  - 1 time in part B
4. Each competition participant is entitled to only one prize within one competition, unless otherwise specified in the relevant competition post.

5. In the event of a tie (Monthly Winners), the Winner will be determined by random selection draw (at least 2 IBU employees will be present).
6. The method of determining the competition winner among the competition participants will be specified in the relevant competition post or via in-game message. The determination of the lottery winner (Part B) will be conducted under the supervision of two employees of the competition Collaborator at its premises, and the winners will be announced no later than 7 working days after the end of the specific competition.
7. Rankings and results of each competition month will be published directly in-game or linked to the website which will be announced via official in-game message.
8. Overall ranking (Jan 1st - March 31st) will be published directly in-game or linked to the website which will be announced via official in-game message.

## VI. Prize and its delivery

### 1. Prizes:

2. The delivery of correct prizes and their functionality is the responsibility of the competition collaborator.
3. The competition winner will be notified about winning the prize no later than 7 working days after the draw or completing the results via the game message in the Winter Sports Mania or via e-mail.
4. All winners (monthly competitions and final lottery) must select a competition weekend (following the conditions specified in the table above) and confirm it to IBU by 15 September 2025.
5. The competition promoter will send the prize to the competition winner no later than 30 days from the date the competition winner provided complete contact details to the competition promoter.

6. The winner is not legally entitled to receive the prize and cannot be enforced in court. The results of the contest shall be final. Tenderers take note that they may not ask for a win of a higher value or quantity. Tenderers also note that the prize cannot be exchanged for cash or require the issuing of a prize other than the one set by the bidder in the respective tender submission.
7. When a player doesn't claim the prize on time or doesn't react to the messages, the competition organizer is not responsible for and the player's entitlement to the ticket expires.

#### VII. Special Provisions

1. Employees of the competition promoter and competition collaborator, as well as individuals closely related to them (a close person is a relative in the direct line, a sibling, and a spouse; other persons in a familial or similar relationship are considered close to each other if they would reasonably feel the harm suffered by one of them as their own loss) are excluded from participating in the competition.
2. If it is proven that the competition winner is an employee of the competition promoter or competition collaborator or a person closely related to them, such person does not have a claim to the prize, the prize will not be awarded, and it will be forfeited in favor of the competition promoter.
3. In the event of reasonable suspicion of fraud, abuse, or an error relating to the proper organization of the competition, the competition promoter reserves the right to terminate or suspend the competition, modify the competition conditions, declare the prize notification published on the POWERPLAY MANAGER, s. r. o. company's website or sent to the winner as invalid or without notice, and block the participation in the competition of any participant who engages in the competition in violation of good morals.
4. The competition promoter is not responsible for the winner providing an incorrect address within the contact information, to which the voucher should have been sent. The competition promoter is also not responsible for any other reasons for which the voucher was not delivered to the winner, except for reasons attributable to the competition promoter.
5. Prizes exceeding the amount specified by the relevant law are subject to income tax in accordance with Act No. 595/2003 Coll. on income tax, as amended, and are also subject to contributions to public health insurance in accordance with Act No. 580/2004 Coll. on health insurance, as amended, with the competition promoter not being responsible for fulfilling the tax or contribution obligations of the competition winner.
6. The competition promoter does not cover any expenses incurred by the competition participants in connection with their participation in the competition.
7. By participating in the competition, each participant expresses their consent to the rules of this competition and acknowledges that the competition promoter is entitled to publish the names, likeness, or other provided information about the winners in promotional materials and use them for advertising and promotional purposes without the competition participant being entitled to any compensation.
8. The competition promoter reserves the right to change the conditions or rules of this competition at any time without prior notice, with the aforementioned change in conditions or rules being obliged to be published on the Facebook page of POWERPLAY MANAGER, s. r. o.

#### VIII. Personal Data Protection

1. By participating in the competition, the competition participant acknowledges that the competition promoter, as the data controller within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council (hereinafter referred to as "GDPR") and Act No. 18/2018 Coll. on the Protection of Personal Data and on Amendments to Certain Acts (hereinafter referred to as the "Act"), processes their personal data, including their name, surname, and possibly a photograph, for the purpose of their publication on the PowerPlay Studio Facebook and Instagram pages as part of the evaluation and announcement of the competition results, from the participant's entry into the competition until the end of the competition or the publication of the

competition results. The aforementioned personal data is processed based on Section 13(1)(f) of Act No. 18/2018 Coll. on the Protection of Personal Data and on Amendments to Certain Acts.

2. For the purpose of prize delivery, the competition promoter processes personal data including the name, surname, email address, and delivery address. The aforementioned personal data is processed based on Section 13(1)(b) of Act No. 18/2018 Coll. on the Protection of Personal Data and on Amendments to Certain Acts for the duration necessary for prize delivery.
3. The rights of the competition participant - data subject regarding the processing of personal data are regulated by Article 15 of the GDPR. The data subject has the right to:
  - request confirmation from the competition promoter, i.e., the data controller, whether personal data concerning them is being processed, and if so, they have the right to access this personal data,
  - request the competition promoter to correct personal data concerning the data subject or to erase or restrict its processing, or the right to object to such processing,
  - lodge a complaint with the supervisory authority, which is the Office for Personal Data Protection of the Slovak Republic, Hraničná 12, 820 07 Bratislava 27, telephone: +421-2-32313214, email: [statny.dozor@pdp.gov.sk](mailto:statny.dozor@pdp.gov.sk),
  - request the provision of a copy of the personal data being processed.
4. For any additional copies requested by the data subject, the data controller may charge a reasonable fee corresponding to administrative costs.
5. Personal data will not be transferred to third countries and will not be used for automated individual decision-making, including profiling.

#### IX. Final Provisions

1. This statute is published and accessible to everyone online at the address: [insert web address]. It is also stored by the competition promoter.
2. Anyone who demonstrates a legitimate interest is entitled to inspect this statute at the competition promoter's premises.
3. The competition promoter reserves the right to change the rules of the competition at any time or to end the competition prematurely, even without giving a reason, without the participant being entitled to any compensation.
